Definitions

"Australian Organic" or "AOL" means Australian Organic Limited.

"Member" means a member of Australian Organic. Members may be of different classes of Membership.

"Ordinary Member" means a Member of Australian Organic from time to time as permitted by the AOL Constitution, having the membership rights set out in clause 8.1.

"Financial Member" for the purposes of the Australian Organic Constitution, means a Member of Australian Organic Limited who has paid in full the most recent instalment of its annual membership fee or who has paid to Australian Organic Limited the most recent levy or other license fee in consideration for holding an Organic Certificate in an amount which is at least the amount payable for the most recent annual membership fee.
